- 1. Greg Walker – Director of Parks & Recreation – reported that everything is alive and jumping now. 62 teams are playing ball – over 700 children signed up to play. He said all 8 fields are in use every night. He encouraged everyone to attend. The opening day was a washout so he is working with ETC to plan something special for closing day. Summer Camp registration is taking place – they have 75 kids signed up. It starts May 30, 2006. The pool will open on May 30<sup>th</sup> also. He said that Eric Chalkiadi and Michael Jones have been working hard toward building more storage, which they need desperately. He thanked the Commissioner for a new mower. He said the master plan is completed and they will be sitting down with W.K. Dickson Co. and going over this. Our Mite girls won district championship and competed in the state tournament up in Dahlonega, Ga. They made it to the semi-finals. Our Midget girls finished district runner-ups. He wants to encourage the public to utilize the parking at the middle school for ballgames because parking is of great concern. They can walk from the middle school through the tunnel to get to the Rec. Department.**

  9. Adopted Joint Proclamation proclaiming May 6, 2006 Health Fair Day in Pickens County.

Adopted Resolution of Pickens County that Pickens County owns all that Tract or parcel of land lying and being in Land Lot 23, 24, 49, 51 and 59 of the 13<sup>th</sup> District and 2nd Section of Pickens County, Georgia, and being 74.4 acres shown as tax parcel no. 041-030 upon the Pickens County Tax Assessor’s map, Pickens County, Georgia records, and by said reference, the above described plat is incorporated herein and made a part hereof. Pickens County shall enter into an intergovernmental agreement with the City of Jasper which shall assure the residents of Jasper and Pickens County that the City of Jasper will not act or refrain from acting in such a manner as to cause a violation of any of the above grant assurances which Pickens County has made or will make to the Federal Government for Pickens County Airport.
