Mechelle Champion, Chief Financial Officer, reported that the Local Option Sales Tax collected in August 2010 compared to the prior month was up \$44,946.77. August LOST compared to August 2009 \$12,105.77. The total cost of the Administrative Center Project was \$3,898,513.20 and the Adult Detention Center cost was \$10,667,015.06. The total for both Projects = \$14,565,528.26. As you know we paid off both projects early which saved on interest. We actually paid \$13,287,323.58 for both Projects. The total savings by paying the notes off early was \$1,278,204.68. Mrs. Champion showed a chart of SPLOST 2003 Revenues and Expenditures broken out by departments: Fire, EMS, 911, Sheriff, Water and Road. She also showed a table for the SPLOST 2008. So far the total is \$7.8 million. She did a comparison of August 2010 to prior month and it is up \$64,249 and August 2010 compared to August 2009 – up \$18,574. Overall we are up 12.15% over 2009.
