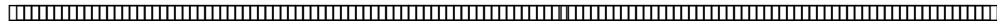

## Required Items to be Attached to this Application

- Copy of recorded Warranty Deed or Lease Agreement
- Copy of property tax bill
- Copy of tax map
- List zoning and verify with Planning & Development staff that the property is currently zoned for the intended use
- Evidence of compliance with Ordinance 6-44 requiring **at least** 600 feet distance from the front door of the structure from which malt beverages and/or wine will be offered for sale in a straight line to the nearest sidewalk, walkway, or street/road/highway; along such sidewalk, walkway, or street/road/highway; to the land (property) line of any school property, educational property, college campus property, or church property.
- Photos of all four sides of the building to be used in the sale of alcoholic beverages
- If the applicant is a corporation or limited liability company, please provide a certificate of good standing issued by the Georgia Secretary of State's office and the company authorization for the individual signer of the application to execute the same for the company. If the applicant is an individual, please provide copy of driver's license or State-issued identification.
- Provide a criminal history issued by the Pickens County Sheriff's Office
- For Farm Winery applications, provide a copy of Federal License and physical address of Tasting room.

Distilled Spirits – three percent (3%) of Gross Sales of Distilled Spirits

Wine – eighty cents (\$0.80) per wine gallon. Based on \$0.00625 per ounce at 128 ounces per gallon
